Bâtirente is committed to climate action

Now, more than ever, there is consensus on the link between human activities and global warming, on the influence of global warming on the economy and investment, and on the need for a focused response.

It is essential for Bâtirente and its governance bodies to demonstrate fiduciary responsibility by allocating the capital entrusted to us by our members toward both reducing greenhouse gases (GHGs) and building resilience to the effects of global warming.

Climate change is certainly one of the ongoing drivers of our action. Carbon

footprint measurement, green bonds, shareholder engagement and the introduction of impact strategies in equity and real estate are the practices we have adopted on this issue to date.

There is now a need to integrate these various elements of our climate action into a coherent approach that includes quantitative and qualitative objectives and an increased mobilization of the means at our disposal. These objectives are commensurate with our size and resources, but also match the colossal civilizational challenge that global warming presents.

Responsible investment leader

For more than 15 years, Bâtirente has worked with strength and conviction to promote sustainable finance, and today is a recognized and respected leader in the industry.



Bâtirente adopted its Guidelines on Extrafinancial Risk Management based on 3 pillars:

- > Environmental, social and governance (ESG) integration by our portfolio managers;
- > Shareholder engagement with companies in our investment portfolios;
- ▶ Increased transparency of businesses relating to their ESG information.



Bâtirente signed the Principles for Responsible Investment (PRI), with the full commitment of the then CEO Daniel Simard. In addition, Mr. Simard became an asset holder representative on the Provisional Board of Directors of the United Nations Association for the Principles for Responsible Investment (UNPRI) upon its foundation, was re-elected twice and continued to serve on the Board for 9 years until stepping down at the end of 2015.



Mr. Simard established the *Réseau PRI Québec* and chaired its advisory committee until 2018. Bâtirente signed the Montréal Carbon Pledge.



Bâtirente founded Æquo, Shareholder Engagement Services in partnership with the *Regroupement pour la responsabilité sociale des entreprises* (RRSE) and transferred all its internal shareholder engagement activities to Æquo with the goal of making these services accessible to the Quebec institutional investment community and beyond.



100% of the Bâtirente Funds are now managed by managers who are signatories to the PRI.

Responding to the urgent need for action, Bâtirente unveiled an ambitious climate commitment.



Bâtirente affirmed its commitment centred on 4 axes: invest, measure, engage and cooperate.

ENGAGE

We hold dialogues with the companies in which we invest to encourage them to implement sustainable business models. We urge financial regulators to increase their requirements to promote sustainable business models.


COOPERATE

What are the Principles for Responsible Investment?

The Principles for Responsible Investment (PRI) were launched in 2006 by investors, including Bâtirente, in partnership with the United Nations. The PRI Association believes that long-term value creation requires a sustainable and economically efficient global financial system. Such a system must reward responsible investment while benefiting the environment and society.

PRI Association members are working to achieve this sustainable financial system by promoting the adoption of the Principles and collaboration in their implementation. The Association promotes good governance, integrity, and investor responsibility, encouraging investors to work to address the structural, regulatory, and practical barriers to the emergence of this system.
