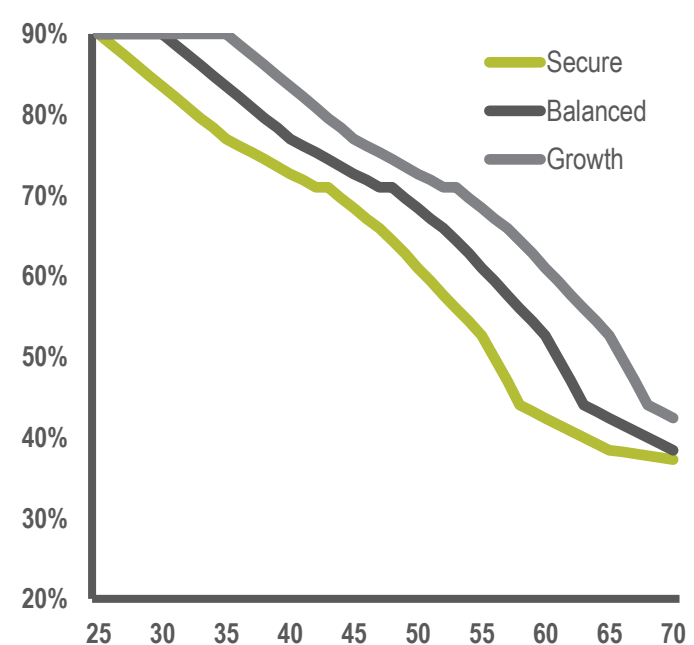
## YOUR TRAJECTORY PORTFOLIO
