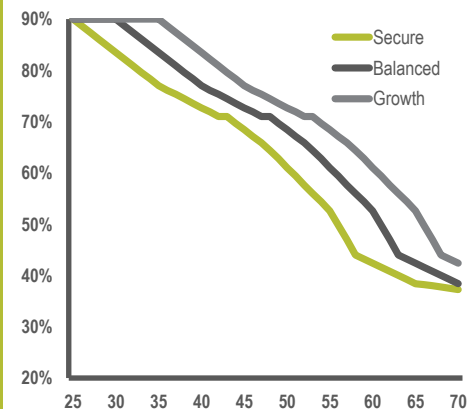
YOUR TRAJECTORY PORTFOLIO
